

OFFICIAL RULES FOR THE “Matt Kenseth Sheet Metal Sweepstakes”

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING

SWEEPSTAKES PERIOD: The Matt Kenseth Sheet Metal Sweepstakes (“Sweepstakes”) begins on July 8, 2016 at 12:01 a.m. Eastern Standard Time (“EST”) and ends on July 22, 2016 at 11:59 p.m. EST (the “Sweepstakes Period”).

All online entries must be submitted by July 22, 2016 at 11:59 p.m. EST to be eligible. Entries generated by script, macro or other automated, or mechanical, means or by any means which subvert the entry process are void. Limit one (1) entry per person, per email address and per household. All entries become the sole property of the Sponsor and will not be returned. Released Parties (as defined below) are not responsible for lost, late, stolen, garbled, incomplete, damaged, delayed, illegible, mutilated or misdirected entries or mail.
