

**OFFICIAL RULES FOR THE
“The Ultimate Fan Access Weekend Sweepstakes”**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING

SWEEPSTAKES PERIOD: The “Ultimate Fan Access Weekend Sweepstakes” (“Sweepstakes”) begins April 12, 2019 at 12:00 AM EST and ends on August 26, 2019 at 11:59PM EST (the “Sweepstakes Period”).

HOW TO ENTER: During the Sweepstakes Period, there are three (3) ways to enter: **(1) Online:** Visit www.RichmondRaceway.com/experiences/ultimate-fan-sweeps.aspx and follow the directions provided to complete the entry form and submit to receive one (1) entry into the Sweepstakes. All online entries must be submitted by August 26, 2019 at 12:00 AM EST to be eligible; **(2) Via Mail:** Handprint your name, address, city, state, zip code, daytime and evening phone numbers (including area codes), and date of birth on a 3" x 5" card and mail the card, with proper postage affixed to: “The Ultimate Fan Access Weekend Sweepstakes” C/O Richmond International Raceway, LLC, 600 E. Laburnum Ave, Richmond, VA 23222; and **(3) On Site:** Call 1-804-228-7636 to hear a schedule to visit selected scheduled community events and fill out the entry form provided to receive one (1) entry into the Sweepstakes. Entries generated by script, macro or other automated means or by any means which subvert the entry process are void. Limit one (1) entry per person, per email address and per household, regardless of method of entry. Entries received from any person or email address or household in excess of the limitation will be void. All entries become the sole property of the Administrator and will not be returned. Released Parties (as defined below) are not responsible for lost, late, stolen, garbled, incomplete, damaged, delayed, illegible, mutilated, misdirected, or postage-due entries or mail. Incomplete, illegible, or fraudulent entries will be void.

ELIGIBILITY: Sweepstakes is open to legal residents of the fifty (50) United States and Canada (excluding Quebec) age 21 or older with a valid driver’s license. Canadian residents must also have reached the age of majority in their province/territory of residence. Cold pit passes and pace car rides are subject to the rules and regulations of Richmond International Raceway, LLC and any applicable sanctioning body.
